## **OBITUARY**

From "the Times" Newspaper 1930 Mr C.D. Im Thurn. "The Zinoveiff Letter"

Mr. Conrad Donald Im Thurn, whose name came into prominent notice two years ago as that of the intermediary through which the famous Zinovieff letter was brought to light, died at 28, Eaton-Terrace, S.W.1, on Saturday, after a year's illness. Mr Im Thurn, who was 47 years of age, was the son of the late Mr. J. C. Im Thurn, of the well-known City firm. He was educated at Radley, but ill-health did not permit him after leaving school at once to enter the family firm. During the War, however, he served with Home Forces, and later was seconded for special duty at the Home Office. Of recent years he had been engaged in financial business in the City. Mr Im Thurn's part in the disclosure of the Zinovieff letter, which figured so largely in the General Election of 1924, was first made public in the House of Commons on March 19th 1928. The Labour Party, with Mr MacDonald as their spokesman, had moved, after the "Frances Case" for a further inquiry into the origin and career of that document. In his reply Mr Baldwin was able to read a statement by Mr Im Thurn, to whose honesty and patriotism Mr. Baldwin paid tribute, disclosing how a copy of the document reached the press. Briefly, Mr Im Thurn stated that a business acquaintance in touch with the Communist Party had revealed to him the existence of the document and procured a copy for him. In his disgust at the advocacy of sedition and in his determination not to let the people vote in ignorance for a Treaty with a loan to it's authors Mr Im Thurn sent a copy to the Foreign Office and to the Press, after an interval sufficient to ensure the security of his informant. He had no regrets. and had no rewards of any kind. Of the authenticity of the document Mr Im Thurn had at no time any doubt. Mr Im Thurn Married in 1906 [Jun Q 1a/1187 St. Marylebone], Miss Ysabel Anita Brooking [b. 1883 Tacna, Chile, d.o. George and Elena Brooking]. She survives him with one daughter [Ursula], who is a medical student at the University College Hospital, and one son [John], who is at Stowe School. The funeral service will be at St Michael's, Chester-square, to-morrow, at 12 noon, and his burial will be at **Butleigh**, Somerset. It is requested that, there be no mourning and that no flowers be sent.
